NOTE:

- (i) In case of Departmental Examination of Tehsildar, only regular Tehsildars (B-16) are eligible to appear in the above said Examination. However, for Naib Tehsildars, those who have passed their Departmental Examination of Naib Tehsildars conducted by the Board of Revenue are also eligible to appear in aforesaid Examination and they are required to submit their result of Departmental Examination along-with their application failing which their application will not be entertained.
- (ii) The Officers/ Officials who have availed the prescribed number of chances are not eligible.
- (iii) The Examination Fee **Rs. 2000/-** should be deposited in the State Bank or National Bank of Pakistan or Government Treasury under the Head **"C-02101-ORGAN OF STATE EXAMINATION FEE BPSC."**
