- (i) In case of Departmental Examination of Tehsildar, only regular Tehsildars (B-16) are eligible to appear in the above said examination. However, the Naib-Tehsildars who have passed their departmental examination of Naib-Tehsildars conducted by the Board of Revenue are also eligible to appear in aforesaid examination and they are required to submit their result of departmental exam of Naib-Tehsildars duly signed by the Secretary, Board of Revenue, Balochistan along-with their application failing which their application will not be entertained.
- (ii) The Officers/ Officials who have availed the required number of chances are not eligible.
- (iii) The Examination Fee of Rs. 2000/- should be deposited through 1Link-1Bill against the PSID generated at BPSC Official Website. (The Guidelines for the submitting online fee is available at official website i.e. www.bpsc.gov.pk)

- (2) The candidates should use only blue or black ink.
- (3) Smoking is strictly prohibited in the Examination Hall.
- (4) Mobile Phone is not allowed in the Examination Hall. So don't bring your mobile phone in the Examination Hall.
- (5) If any candidates is detected copying or found guilty any other misconduct, such candidate shall be expelled from the Examination Center forthwith and shall be debarred from appearing in the subsequent papers.
- (6) Before attempting the paper, the candidates should check the page marking of the answer sheets and if found any mistake in the page marking, should bring it in the notice of Center Supervisor.
- (7) The candidates must write their Roll Number, Name and parentage only on the slip affixed on the answer sheet.
- (8) The candidates may use the last page of answer sheet for rough work. Rough work should not be done on question paper or extra paper.
- (9) Any kind of identification marks in the answer sheet will lead to cancellation of your paper.
- (10) If any candidate feels any problem, he should raise his hand; the supervisory staff will attend him. Making clamor and roaming freely in the Examination Hall is not allowed at all.
